Other matters not affecting our opinion which we draw to the attention of the council:

The previous auditor raised concerns over the reduction in value of a number of assets. No action appears to have been taken to address those concerns. Where this is unknown a proxy value can be used – for example, the insurance value when the asset is first recorded. Thereafter there should be no increases in valuation or reductions due to depreciation or impairment. The only movement should be on disposal or later acquisitions. We note that the Responsible Financial Officer and Internal Auditor bear the same surname. We have assumed that they are related. If our assumption is correct, please note that it is not acceptable for the two posts to be occupied by persons related. The internal auditor must be independent.
