3. Minutes of the last meeting on January 28th 2014.

4. There were no additional registrations of interest.

5. Matters arising from the previous meeting:

a) Dog waste bins

DG and BK have spoken to members of HBC. There is no current provision for supplying or emptying newly installed bins and the feeling of the meeting was that visitors would have to be responsible for removing their own dog waste.

b) Footpath through Manor Farm

There was no up-to-date information on this.

c) Reserve signs on village green

JH has this in hand. The siting of the sign on, or attached to, the PC noticeboard was discussed.

There is no budgeted money available from YWT for a free-standing sign this year.

d) Wildflower project

DG and JH have contacted Bernadette Lobo and the School but have not had further contact so far.

The project is planned to go ahead with DG sowing and raising seedlings this year ready for planting out in the orchard area next spring.

6. YWT report

The original plans are underway now and further developments include:

Eastfield re-wetting is going well with 10cm of topsoil removed and deep furrows created, with fine grass sown to create a matrix for a fen community. Widgeon and teal have over-wintered there. There is now a permanent fence to control grazing areas. Highland and White Park cattle to be grazed again with sheep later in the year.

Weed control will continue using a "wiping" system as well. Success in some areas in removing himalayan balsam. Some japanese knotweed, thistles etc need ongoing control.

Hay meadow was re-seeded last year and is looking good – lots of cowslips.

7. Chairman's report.

8. Future Reserve Plans

A reed bed is to be developed near the new hide.

The flooding of the River Tutt is not the responsibility of the I.D.B. (Internal Drainage Board)— YWT hope to place an impermeable bund along the bank to control the flooding.

Possible future plans to "meander" the river further down were discussed.

The feeling of the meeting was that this could cause further congestion and litter problems at the car park. It was suggested that the person might consider approaching the village hall committee re this idea.

DG reported that she had had some discussion and correspondence with the PC over the holding of meetings when the YWT representative is unable to attend. It was felt that in the circumstances commented on, where DG and JH had had telephone discussions prior to the meeting, that such a meeting could still be useful and should generally go ahead at the discretion of the chairman.
