1. To Receive Apologies

Apologies were received from HBC Councillor Anthony Alton, Parish Councillor N Stringer and Parish Councillor L Manby.

2. To Receive Declarations of Interest

None declared.

3. To Confirm Minutes of the Meeting of 24 September 2015

The minutes of the meeting were accepted as a record.

4. Items Brought Forward From the Last Meeting

4.1 Access to Staveley Nature Reserve through Manor Farm

It was confirmed that NYCC were in the process of seeking tenders for providing a hard surface to the path.

The PC confirmed that it will not support any other work to footpaths.

4.2 Car Parking

Car parking during YWT events was discussed. The PC was advised that YWT was unable to pay for parking.

YWT to be requested to provide signage to the Liaison group.

YWT to be asked for their suggestions to alleviate parking problems in the village.

4.3 River Tutt Modifications

The PC confirmed that the river forms part of the drainage system for the village and it expressed concern that YWT was considering introducing meanders to the water course. It was suggested that the proposed work would adversely affect flow rates resulting in flooding. The PC was advised that any work would be monitored by the drainage board.

The PC was concerned that the drainage board had not been able to clear section of the water course near to the fish ponds because of tree obstructions.

4.4 Verges

Stated that the verge between the old railway bridge and Halesfield will be included in the cutting contract for the 2016 season.

Confirmed the hedges at the Recreation field would be cut.

PC confirmed that trash screens had been blocked and caused flooding to Arkendale Road.

4.5 BT Phone Box

Discussions deferred to the next meeting.

4.6 Highways

It was noted that the PC had been unable to arrange a meeting with NYCC to progress outstanding issues. Cllr. Windass agreed to liaise.
